No. GHKH/16/2013/RCT/1108/2879/P-2:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Veterinary Officer, in the Gujarat Animal Husbandry Services, Class II, namely:-

1. These rules may be called the Veterinary Officer, Class II, in the Gujarat Animal Husbandry Services, Recruitment Rules, 2013.
2. Appointment to the post of Veterinary Officer, Class II, in the Gujarat Animal Husbandry Services, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
(a) not be more than thirty five years of age,

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(b) possess,

(i) a degree in Veterinary Science and Animal Husbandry (BVSc & AH) or a degree in Veterinary Science or Animal Husbandry (BVSc or AH) from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956 and have been recognized under Indian Veterinary Council Act, 1984;

(ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and

adequate knowledge of Gujarati or Hindi or both.

A candidate appointed by direct selection shall be on probation for a period of two years.

A candidate appointed by direct selection shall during probation period require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006.

A candidate appointed by direct selection shall require to pass departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

A candidate appointed by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.

A candidate appointed by direct selection shall get himself registered with the Gujarat Veterinary Council or Veterinary Council of India statutory bodies established under the Indian Veterinary Council Act, 1984 at the time of making application; if not so registered.

A candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such a period as may be prescribed by the Government.


