No.(GN-44)TSM-222008-4198-GH:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Accounts Officer, Class II, in the Gujarat Accounts Service under the Directorate of Accounts and Treasuries, Gujarat State, namely :-

1. These rules may be called the Accounts Officer, Class II, in the Gujarat Accounts Service under the Directorate of Accounts and Treasuries, Recruitment Rules, 2016.
2. Appointment to the post of Accounts Officer, Class II, in the Gujarat Accounts Service under the Directorate of Accounts and Treasuries, Gujarat State, shall be made either, -
  - (A) (a) by promotion of a person of proved merit and efficiency from amongst the persons, who, -
    - (i) have worked for not less than seven years in the cadre of Accountant, Class III, in the subordinate service, under the Directorate of Accounts and Treasuries, Gujarat State;
    - (ii) have passed the qualifying examination for computer knowledge in accordance with the

provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006; and

(iii) have passed the prescribed departmental examination for promotion to the post of Accounts Officer, Class II :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

(b) by promotion on the basis of the result of the special competitive examination held by the Gujarat Public Service Commission of a person of proved merit and efficiency from amongst the persons, who, -

(i) have worked for not less than five years in the cadre of Accountant, Class III, in the subordinate service under the Directorate of Accounts and Treasuries;

- (ii) have passed the prescribed departmental examination for promotion to the post of Accounts Officer, Class II;
- (iii) possess a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government; and
- (iv) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006; or

(B) on the basis of the result of the competitive examination.

3. The appointment by promotion from the cadre of Accountant, Class III under the sub-clauses (a) and (b) of clause (A) of rule 2 and on the basis of the result of the competitive examination under clause (B) of rule 2 shall be in the ratio of 5:1:4 respectively.

4. To be eligible for appointment on the basis of result of a competitive examination to the post mentioned in rule 2, a candidate shall,—

- (a) not be more than 37 years of age;
- (b) possess the qualification of Chartered Accountant or Cost and Works Accountant(I.C.W.A.) or Company Secretary or at least a second class degree in Bachelor of Business Administration or Bachelor of Commerce or Bachelor of Science in Mathematics or Statistics as a principal subject or Bachelor of Arts in Statistics or Economics or Mathematics as a principal subject or Bachelor of Computer Application obtained from any of the Universities or institutions established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (d) possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed on the basis of the result of the competitive examination shall be on probation for a period of two years.
  6. The candidate appointed on the basis of the result of the competitive examination shall, during his probation period, require to undergo pre-service training and pass the post-training examination in accordance with the Gazetted Officer's Pre-service Training and Examination Rules, 1970.
  7. The candidate appointed on the basis of the result of the competitive examination shall during his probation period require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
  8. The candidate appointed on the basis of the result of the competitive examination shall require to pass the departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
  9. The candidate appointed either on the basis of the result of the competitive examination or by promotion shall require to undergo such training and pass such examination as may be prescribed by the Government.

10. The candidate appointed on the basis of the result of the competitive examination shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.


