- 1) The candidates at Rank Nos. 02 (SEBC) and 10 (S.C.), are to be recommended for appointment on unreserved post as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have not availed any relaxation.
- 2) The candidate at Rank No. 08 (S.C.-Fem.), though secured her place in the merit of general category, however she is to be recommended for appointment against the post reserved for S.C. category, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as she has availed the benefit of relaxation in qualifying standard in the preliminary test.
- 3) 05 posts of SEBC, 01 post of S.C., 02 posts of S.T. category, remained vacant, as no suitable candidates were available for the same.
- 4) Posts reserved for Disabled candidates and Ex-Servicemen remained vacant, as no candidates were available for the interview.
