## Corrigendum

The result of the interviews for the posts of Gujarat Education services , class-II Advt. No. 116/2013-14 was declared on 27<sup>th</sup> January ,2017, in which 16 posts were kept vacant and the result of 12 candidates kept in abeyance.

The Hon. High Court has directed the Commission to publish the result of the petitioner( Kum. Heena Sanjaybhai Patel ) and give the effect within a week , in C.A No. 2717 of 2017 in SCA No. 14963 of 2016 . As per the Commission's decision dated 14<sup>th</sup> march on File No. SCA-14963-2016-R7, the result of Kum. Heena Sanjaybhai Patel and other 09 candidates ( called for interview on similar ground ) is to be declared .Out of 10 candidates 01 candidate bearing E.No. 1045 is to be declared successful (against 01 post of General Male category kept vacant ) in the recommendation list at appropriate place i.e at Rank No. 69-A( between 69 and 70 ) and details are as shown below :
